Each service credit expires (60) days in total after the membership fee has been charged. When utilizing the rollover extension, AgeLess SPA permits the use of one rollover service per month. You may extend your expiring “rollover” service an additional (30) days by paying a \$10 fee. In order to take advantage of the rollover extension please note AgeLess SPA requires a minimum of a 24-hour notice to extend. AgeLess SPA continues to adhere to an Appointment Cancellation Policy and kindly ask that you provide us with a 24-hour cancellation notice or the appointment will be considered a used treatment. By adhering to our Cancellation Policy, any appointment properly cancelled will not count as a used treatment. Memberships, benefits, and complimentary services are non-transferable and non-refundable. Memberships auto-renew and have no initiation fees.

Your credit card and email address is required for participation in our Wellness Membership Program. Your credit card will remain securely on file and each month your credit card will be charged the amount recorded on the same date each month, “monthly due date”. *Please note, our secure system only allows us to see the last 4-digits of your credit card number.*

This agreement may be terminated at any time by a member provided that at least 30 days' notice is provided in advance of your monthly dues due date. As of the effective date of a termination, any unused rollovers will expire. AgeLess SPA reserves the right to modify the terms and conditions of the Wellness Membership Program upon advance prior written notice. AgeLess Wellness Memberships are a minimum of 90 days. Membership terminations must be a (30) day advance written and signed notification by all parties associated to the membership.
